

Green Ballast Daylight Harvesting and Dimming Electronic Fluorescent Ballast 5-Year Limited Warranty

Green Ballast, Inc. ("GBI") warrants to the purchaser that its electronic fluorescent ballasts will be free from defects in material and workmanship as conditioned herein for a period of five (5) years from date of installation (or date of manufacture if installation date is not known). If the ballast fails to operate during the warranty period, GBI will provide replacement ballast and either handle the installation(s) itself, or pay \$10.00 per ballast to defray ballast installation costs.

Notwithstanding the foregoing, this warranty is not applicable, and is voided as to any product manufactured by GBI which is not stored, installed, operated and/or maintained in accordance with:

- The Standards for Safety of Underwriters Laboratories, Inc. (UL)
- The Standards for the American National Standards Institute (ANSI)
- The National Electric Code (NEC)
- The Specific Instructions Provided by GBI for the Installation of the Product(s)
- Accepted industry practices

This warranty will not apply in the event of conditions demonstrating abnormal use or stress, such as case temperatures in excess of 70 °C, over/under voltage conditions, excessive switching cycles, defective lamp sockets, or improper installation.

The warranty set forth herein is in lieu of any and all other warranties, whether expressed or implied, including the warranties of merchantability and fitness for a particular purpose. In no case shall GBI be obligated or liable for any indirect, consequential, or incidental damages for breach of this or any other warranty, whether expressed or implied, whatsoever.

Should at any time within the stated five (5) year period from the date of installation (if registered; date of manufacture if not registered) any appearance of defect in material or workmanship appear, the purchaser must notify GBI by calling 800.409.1453. Written notice may be mailed to the address listed below.

As a condition to qualify for ballast (no allowance for lamp) replacement under the provisions of this limited warranty, defective ballasts must be available for return to GBI at its request for inspection and test analysis. Prior written approval for return must be obtained from GBI. GBI reserves the right to examine all failed ballasts, and reserves the right to be the sole judge as to whether any ballast are defective and covered under this warranty.
